March 4 to 7, I along with our Dept. NH VFW Cdr. Dennis Querrard, Sr. Vice Cdr. Andy Corrow and National Council Member Leon Rideout attended our VFW Washington DC Legislative Conference. We also attended the ceremonies to honor the VFW National winners of the Patriot Pen (P.P), Voice of Democracy (VOD) and Teacher Awards. Our NH VOD contestant Thatcher Debowski from New Boston NH was awarded \$1,500. Our P.P. Fifth Place Winner Wenonah Brewer-Nyborg, from Franconia, NH, was awarded \$2,500.

At all our legislators' meetings Cdr. Dennis Querrard brought up an issue he was made aware of by the NH Veterans Home (NHVH) Commandant Kim McKay.

As a direct result, Michael Kans, council for US Senator Jeanne Shaheen informed us that he talked to NHVH Commandant Kim MacKay that evening.

She indicated that the NHVH needed immediate help so the VA wouldn't rescind the 2018 grant they received to expand the facility. In fact, she said that the VA had told her that today was the deadline to sign a contract, or they would lose these funds. They've had problems, as noted during yesterday's meeting, with cost growth and the new Build America, Buy America (BABA) requirements. The office reached out immediately to the VA last night, and talked to their head of Congressional Affairs who committed to doing everything she could to stop that outcome. Michael touched base with her again this morning, and she said VA HQ stakeholders were having a call this morning.

The next morning, Commandant MacKay called Michael back and shared that the funding for the State Veterans Home will not be yanked. The VA has removed any deadlines for this grant. The VA will allow the State Veterans Home to solicit bids for a 100% design contract (instead of the 30% design contract they put out for bids), and this will allow for more accurate bids.

The VA will not issue blanket BABA waivers but will consider case-by-case waivers. The VA is also actively helping to locate BABA compliant vendors and suppliers. The VA committed to quarterly meetings with Commandant MacKay to make sure all is well with the project.

Finally, they told her that our NHVH project ranks 5th out of 190 and will almost certainly not have its funding threatened.

Counsel Michael Kans thanked Cdr. Querrard for flagging this issue to the Senator so that they could act on it in a timely fashion.

VFW National Commander Testifies Before Congress: VFW National Commander Duane Sarmiento testified before a joint hearing of the Senate and House Committees on Veterans' Affairs. The VFW delivered its top legislative priorities of cracking down on predatory claims companies, improving VA benefits data sharing for suicide prevention, including accredited claims representatives in transition assistance programs, and removing offsets from concurrent receipt policies. Sarmiento stated the VFW strongly supports the *GUARD VA Benefits Act* to reinstate penalties for charging veterans unauthorized fees for submitting VA claims, and explained that Claim Sharks are spending millions of dollars to lobby against this bill, which is stalling a federal fix. "It's distasteful that these Claim Sharks take money from veterans. But it's disgusting that they take money from survivors," Sarmiento said.

Major Richard Star Act Press Conference:VFW Department of Montana Adjutant/ Quartermaster Tim Peters spoke at a press conference on H.R. 1282/S. 344, *Major Richard Star Act*, alongside Sen. Jon Tester (D-MT); Rep. Gus Bilirakis (FL-12); Sen. Mike Crapo (R-ID); Tonya Star, the widow of Major Richard Star; and other veteran advocates. "Our veterans cannot afford to continue losing their full earned military retirement pay because Congress insists on saving money at their expense," said Peters. "It is time to stop talking about this bill and get it done!" With consistent and overwhelming bipartisan and bicameral support, this legislation would permit combat injured and medically retired veterans with less than 20 years of service to receive their full earned retirement pay and disability compensation without reduction. The press conference was heavily attended by VFW members from across the nation, as it coincided with the annual VFW Washington Conference.

Vet the Vote: March 11-15 is National Civic Learning Week. Participate in this nonpartisan event by registering to vote or checking your voter registration status. The program also provides volunteer opportunities for veterans and military families to support their local communities by becoming poll workers in time for election day.

BATTLE OF THE MONTH



The **siege of Vicksburg** (May 18 – July 4, 1863) was the final major military action in the <u>Vicksburg campaign</u> of the <u>American Civil War</u>. In a series of maneuvers, <u>Union Major General Ulysses S. Grant</u> and his <u>Army of the Tennessee</u> crossed the <u>Mississippi River</u> and drove the <u>Confederate Army of Mississippi</u>, led by <u>Lieutenant General John C. Pemberton</u>, into the defensive lines surrounding the fortress city of <u>Vicksburg</u>. <u>Mississippi</u>, leading to the successful siege and Confederate surrender.

Vicksburg was the last major <u>Confederate</u> stronghold on the Mississippi River; therefore, capturing it completed the second part of the Northern strategy, the <u>Anaconda Plan</u>. When two major assaults against the Confederate fortifications, on May 19 and 22, were repulsed with heavy casualties, Grant decided to besiege the city beginning on May 25. After holding out for more than 40 days, with their supplies nearly gone, the garrison surrendered on July 4. The Vicksburg campaign's successful ending significantly degraded the Confederacy's ability to maintain its war effort. This action, combined with the surrender of the downriver <u>Port Hudson</u> to Major General <u>Nathaniel P. Banks</u> on July 9, yielded command of the <u>Mississippi River</u> to the Union forces, which held it for the rest of the conflict.

The Confederate surrender on July 4, 1863, is sometimes considered, combined with General <u>Robert E. Lee</u>'s defeat at <u>Gettysburg</u> by Major General <u>George Meade</u> the previous day, the <u>war's turning point</u>. It cut off the <u>Trans-Mississippi Department</u> (containing the states of <u>Arkansas</u>, <u>Texas</u> and part of <u>Louisiana</u>) from the rest of the Confederate States, effectively splitting the Confederacy in two for the rest of the war. Lincoln called Vicksburg "the key to the war".^[4]



Expansion of Health Care Eligibility for Toxic-exposed Veterans Frequently Asked Questions

Background

On August 10, 2022, the Honoring our PACT Act of 2022 ("the PACT Act"; Public Law 117-168) was signed into law. Amendments made by section 103 of this law expanded health care eligibility for three new cohorts of toxic-exposed Veterans. VA is making these changes effective March 5, 2024.

What changed with this expansion of care?

Under the PACT Act, all toxic-exposed Veterans were supposed to become eligible for VA care on a phasedin schedule between now and 2032, but it allowed VA to accelerate this schedule. VA chose to do so, and beginning in March 2024, Veterans who were exposed to toxins or other hazards while serving our countryare now eligible for VA care.

This expansion included:

- Cohort 1: Veterans who participated in a toxic exposure risk activity (TERA), as defined by law, while serving on active duty, active duty for training, or inactive duty training. Veterans can locate military exposure categories on VA's Public Health website at: <u>www.publichealth.va.gov/exposures/</u>.
- Cohort 2: Veterans who were assigned to a duty station in (including airspace above) certain locations during specific periods of time:
 - On or after August 2, 1990, in the following countries: Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia, Somalia, or the United Arab Emirates.
 - On or after September 11, 2007, in the following countries: Afghanistan, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, Uzbekistan, or any other country determined relevant by VA. (Note: VA has not determined any other country relevant at this time.
- Cohort 3: Veterans who were deployed in support of Operation Enduring Freedom: Operation Freedom's Sentinel, Operation Iraqi Freedom, Operation New Dawn, Operation Inherent Resolve, and Resolute Support Mission.

How could this impact me?

Under these authorities, eligible Veterans can receive hospital care (including mental health services and counseling), medical services, and nursing home care through VA and will be assigned to Priority Group 6 unless eligible for assignment to a higher Priority Group.

If you are an existing VA health care enrollee in Priority Group 7 or 8, you may be eligible for a higher Priority. Group if you qualify under one or more of these authorities.

Eligible Veterans are exempt from copayments for VA medical care and medications that could be related to their qualifying service. Care that is determined to be unrelated to qualifying service will be subject to any applicable copayments.

How can I apply?

VA is reviewing its enrollment records to determine if Veterans qualify under Cohort 2 or Cohort 3 (Veterans who served in certain locations during certain time periods since August 1990, or who deployed in support of certain contingency operations). Many of these Veterans do not need to take action; VA will be able to upgrade their Pdority Group without further action on the Veteran's part and will notify such Veterans of this change.

if you believe you meet the eligibility criteria for one or more of the cohorts above and you have not been notified by VA that your Priority Group has been upgraded, please complete and submit VA Form 10-10EZR. Health Benefits Update Form, and <u>copies</u> (*not originals*) of supporting documentation. The most convenient way to send us your VA Form 10-10EZR and supporting documentation is by submitting them online at <u>www.va.gov/health-care/update-health-information/</u>. However, you can send us your completed VA Form 10-10EZR and supporting documentation is one of the following ways:

Important: When mailing supporting documentation, only submit COPIES, and retain your originals.

If you would like to submit copies of additional supporting documentation, there is no time limit. However, we strongly encourage you to send any additional information as soon as possible.

Supporting documentation for Cohort 1 (TERA) could include:

- What you were potentially exposed to
- · When (month and year) and where you were exposed
- Type of activity you were engaged in at the time of each potential exposure, such as basic training, involvement in a test or experiment, or type of work done during service.
- Personal statements
- Buddy statements
- Unit histories
- News articles
- Additional evidence lincluding, but not limited to, a personal journal, diary, and/or photos)

Supporting documentation for Cohort 2 and/or 3 could include:

- DD-214 (Discharge)
- DD-215 (Discharge Update)
- Service records
- Military orders
